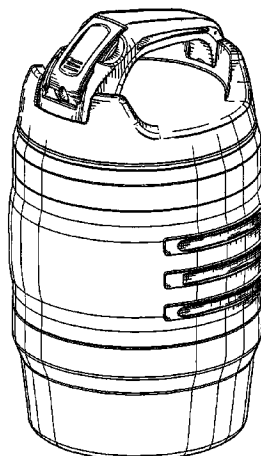
(57) **CLAIM**

The ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a container showing a new design.  
FIG. 2 is a front elevation view thereof.  
FIG. 3 is a right side elevation view thereof, the left side being a mirror image thereof.  
FIG. 4 is a back elevation view thereof.  
FIG. 5 is a top plan view thereof; and,  
FIG. 6 is a bottom plan view thereof.  
The broken line in FIG. 6 represents an unclaimed boundary of the design.

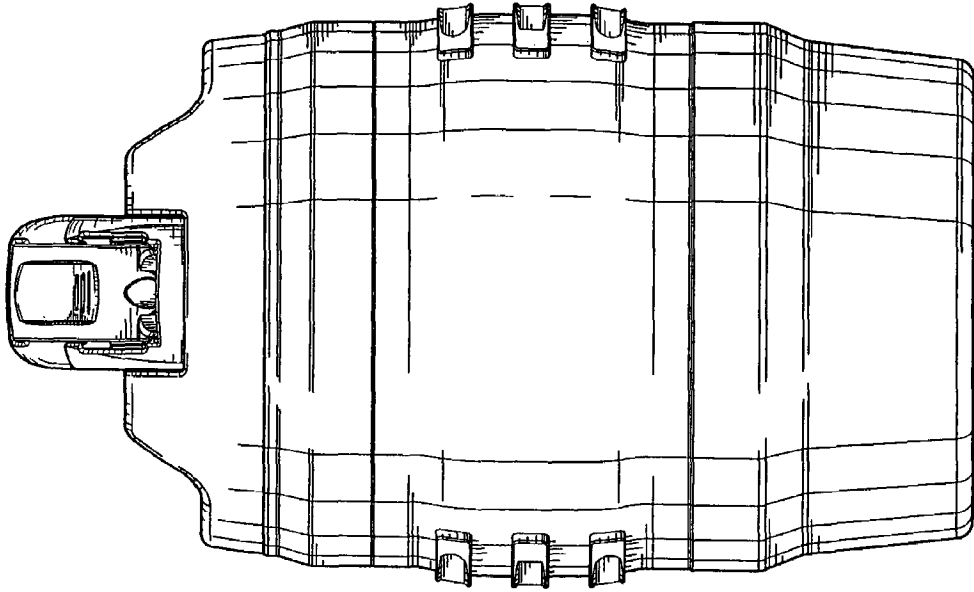

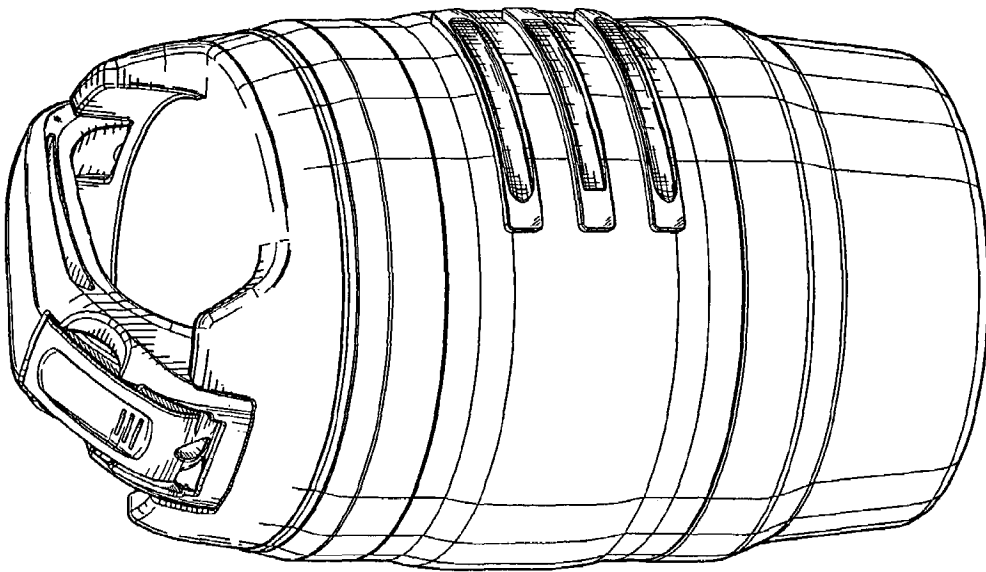

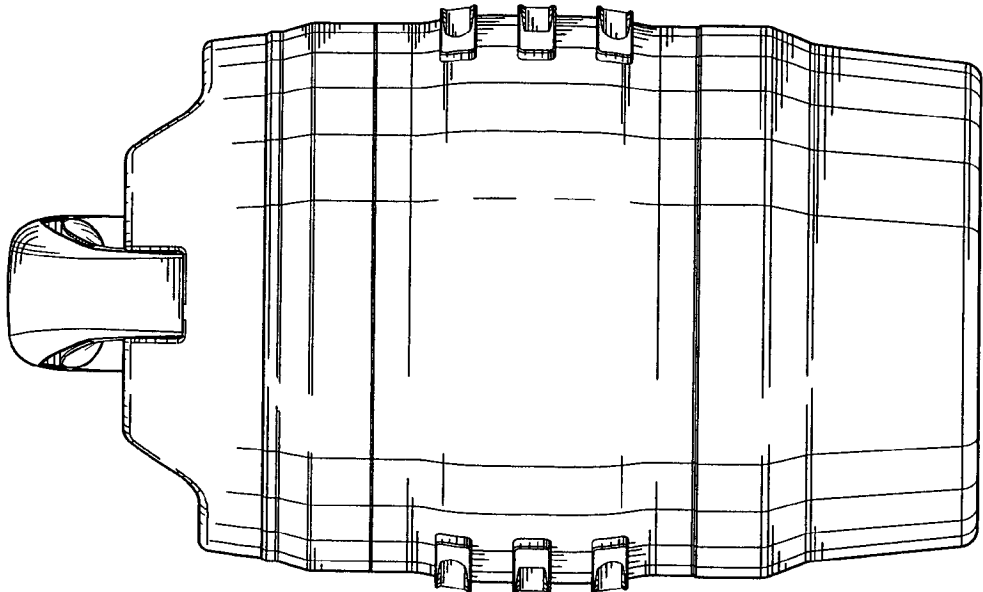

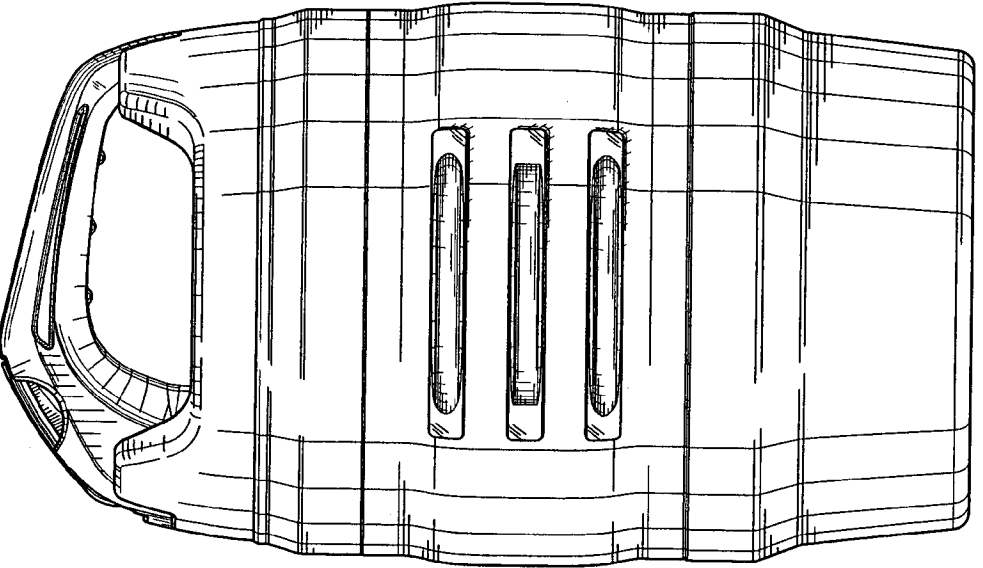
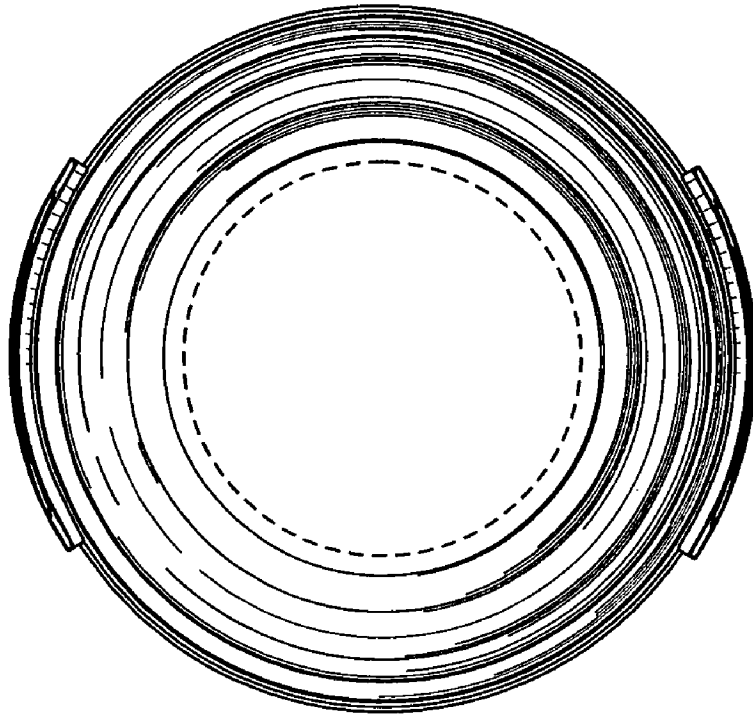
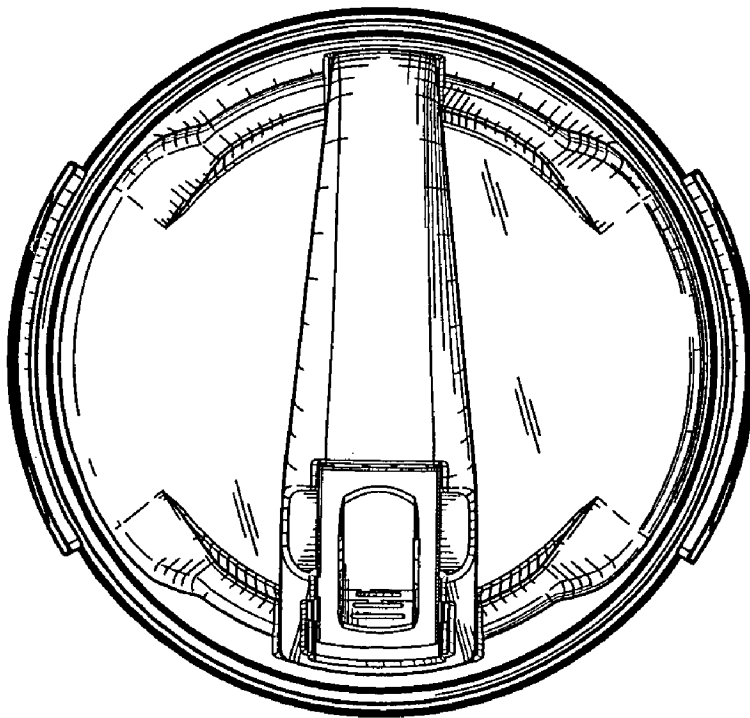
